•09-28-06 - Conferred with the (Philadelphia Tiger Team) about procedures for requesting nationwide VA exams.

•01-17-07 - Received claims list from DTRA to begin processing the Skin Cancer Cases



### A = ATOMIC OR ATMOSPHERIC CLAIMS BASED ON EXPOSURE TO IONIZINGRADIATION


- MILITARY PERSONNEL WHO SERVED WITH THE AMERICAN OCCUPATION FORCES AT HIROSHIMA AND NAGASAKI. (AUGUST 1945 TO JULY 1946)
- THOSE WHO PARTICIPATED IN THE U. S. ATMOSPHERIC NUCLEAR TESTING (1945 TO 1962)
- THOSE WHO WERE INTERNED AS POW'S (NEAR HIROSHIMA AND NAGASAKI) AT THE END OF WWII.

# O = "OCCUPATIONAL" EXPOSURES ASSOCIATED WITH SPECIFIC MILITARY DUTIES.


- PERFORMED SERVICE ACTIVITIES, SUCH AS WORK AS AN X-RAY OR DENTAL TECHNICIAN


## **CLAIM TYPE BREAKOUT**




## **Received vs. Returned**




### Service Connection Granted




### **RADIATION CLAIMS DENIED**






## TOTAL READJUDICATION CASES - 991

### OBSTICALS TO MEETING OUR INITIAL EXPECTATIONS FOR THE RADIATION PROJECT

- WHEN THE PROJECT WAS ACCEPTED, THE VBA CLAIMS TRACKING SYSTEM INDICATED ONLY 2700 RADIATION CLAIMS PENDING NATIONWIDE. OUR ORIGINAL PLANS WERE MADE BASED ON THAT NUMBER. WE RECEIVED SUBSTANTIALLY MORE CASES THAN WERE ORIGINALLY SHOWN AND CONTINUE TO RECEIVE APPROXIMATELY 30 40 NEW CASES PER MONTH.
- ONE OF THE PRIMARY MOVING FORCES BEHIND THE CENTRALIZATION OF THIS PROJECT WAS THE INCONSISTENT NATURE OF BOTH THE DEVELOPMENT AND OVERALL PROCESSING OF RADIATION CASES ACROSS THE COUNTRY. WE FOUND THIS PROBLEM TO BE SOMEWHAT WORSE THAN EXPECTED, I.E., A MAJORITY OF THE CASES HAD BEEN INADEQUATELY DEVELOPED.
- THE SCHEDULING OF VA EXAMS NATIONWIDE HAS PRESENTED SIGNIFICANT PROBLEMS.
- Some VA REGIONAL OFFICES USE CONTRACT MEDICAL FACILITIES AND OTHER VAMCS ONLY SCHEDULE CERTAIN TYPES OF VA EXAMS. THIS CAUSES SOME UNEXPECTED DELAYS IN PROCESSING.
- OUR INFORMATION SHARING RELATIONSHIP WITH DTRA HAS DEMONSTRATED CONSISTENT
- IMPROVEMENT, HOWEVER, WE CONTINUE TO EXPERIENCE DELAYS IN RECEIPT OF INFORMATION FOR OCCUPATIONAL CLAIMS FROM SEVERAL OF THE SERVICE DEPARTMENTS. WE CONTINUE TO EXPLORE WAYS TO IMPROVE THESE RELATIONSHIPS, BUT PROGRESS HAS BEEN SLOW.
