### VBDR Charter (Communications)

### Key Communications Issues We Have Addressed

•Status of the IRR Newsletter (normally released to Atomic Veterans and other Veterans who had any exposure to ionizing radiation while serving on active duty AND have been added to the Ionizing Radiation Registry)

•Projected release date is January/ February every year in order to describe the upcoming VBDR meeting and to review issues raised at the last VBDR meeting

•May be Special Issue to address concerns raised at this meeting on McMurdo/Fukushima



## VA/DTRA Brochure

•Reviewed the status of the VA Atomic Veteran Brochure explaining the Dose Reconstruction Program and the VA' s Claims Program. Final draft came to VBDR prior to distribution in the Fall of 2011

•Discussed distribution to the VARO in Jackson, MS, all Medical Centers and Clinics, all VAROs and other VA Offices, and VA Cemeteries

•Will be the primary vehicle for communicating Atomic Veteran information to Veteran's organizations
